This year the outing is to Arley Hall Gardens in Cheshire on 22nd June, they are holding a garden festival at the time of our visit. The cost is £22.50. He thanked the committee for all their hard work over the past year especially Ronnie for her excellent catering, Phil and Alan for 'heavy lifting' and L. Dibley as auditor. He stressed the need for more committee members to share the work. He stated that with rising costs and overheads it is important that members pay their £8.00 annual subscription promptly. He concluded by thanking everyone for their interest and support.

6. Treasurer's Report

Diana handed out the accounts sheet for the year and reported that financially this has been a better year than last year as we have made a profit of £64.24. This may be slightly deceptive as this includes the fees of 6 new members who joined in the summer. We now have 40 members. The two shows made a loss, but the plant sale, outing, and bulb sales made a profit. This year the account was transferred from HSBC to Lloyds and all the funds are now in one account. There is £1512.88 in the bank and £58.00 cash in hand.
